Marianne,

Some news but still nothing really definite; I have spoken this evening at some length to the Supreme Court Office.

It seems that the judgment could be given by the full court either just before Easter or, if this is not possible, then sometime after 17 April [following the Easter break].

If it was possible this month then I envisage the week starting 26 March would be the most likely.

As always I will keep you posted. It seems that the usual arrangements for the judgment will not apply in this case. There will be no embargoed copy sent to the parties' lawyers some days beforehand, so that it can be proof checked and any factual errors corrected.

It seems that the court is proposing to let the parties know the date very shortly beforehand and then to let them see the judgment at court for an hour or so before it is given. I believe this procedure would be unique.

Marianne,

I am so sorry for the short delay in writing to you. I attach a note of the second and final day of the appeal.

The team is still dealing with further laborious material [to be submitted in writing] for the Supreme Court. It is just amazing how the work is still relentless.

Absolutely no indication when judgment will be given. I envisage at least 6 weeks. The court seems rather troubled by the whole question of other countries having such a wide interpretation of 'judicial authority' in particular how it. can include prosecutors or officials from Ministries of Justice.

I would stress again that it is UK law which under the judicial spotlight not Swedish law [or a Swedish DPP].

One thing which I can say, without any reservation, is that Clare 'really did you proud' as we say here.

I will keep you posted with any news. I will also try to speak with you shortly and will happily deal with any questions or issues which you have.

During the last few weeks I have had to gather numerous pieces of information from foreign [EU] countries about their EAW systems. Their helpful responses, in absolutely every case, have been fantastic. That is what the Framework Decision and international judicial cooperation should be all about.



Marianne,

Always the way, I took a couple of days off last week and came back to find the court has listed the case for judgment on Wednesday. Plans are all in hand at this end. has her details.

The court will not [as it usually does] provide an embargoed draft of the judgment to the lawyers in the case some days prior to the hearing. I believe this is to ensure that there is no question of any possible leak of information. We will see it at 8.30 am [prior to a 9.15 am court] An electronic version should be issued on the Court's website between 9.15-9.30 am. I envisage that the court will simply refer to the contents of full judgment, which is on the website and provide a shorter abbreviated version orally in court [for the benefit of the press and general public].

I will catch up with you on Wednesday/Thursday. I promise I will not leave the country, no matter what.

Please always remember, it is the UK system and its laws which are under scrutiny by the court and not those of Sweden.


