

My colleague has kindly tried to flush out some information from the Supreme Court about possible dates. His response is below.

My best guess is next month. As always I will be touch as soon I have news. The concern of other agencies here [such as the Home Office and SOCA] is that there is now a large back log of extradition cases which are in abeyance pending the outcome of Assange. However I cannot stress enough that it is the UK system and law which are in issue and most definitely not the Swedish ones.

Please let me know when you are due to go away and I will liaise with you [and perhaps are all so we can plan for all contingencies, as usual.
