

About the Crown Prosecution Service

We are called the **CPS** for short.

Our job is to decide whether someone should be taken to court because we think they have committed a crime.



We work with the police when they start looking into a case and decide what charge is best when cases are more complicated.



We also give information and support to:

 people have been the victims of crime



people who will be speaking in court saying what happened to them or what they saw.





We work across England and Wales.

In 2014 we took over 680,000 people to court.



Most went to magistrates courts who deal with less serious crimes.

Nearly 100,000 more serious cases went to Crown Courts.



About 8 out of 10 people were found guilty of doing the crime.

We must make decisions that:

do enough to get the right results in court.



• act on the things people are worried about.

It will be more difficult as we don't have so much money and we are changing the way we work.

We need to stick to the things we believe in to make sure we carry on treating people in the ways we want to.

The Law

The Equality Act 2010 said people should be treated equally and fairly, and especially people not be treated unfairly because of:

how old they are



a disability they have



having changed sex



being married or in a civil partnership



• having a baby



• their race





their religion or belief



being a man or a woman



• being gay, lesbian or bisexual.



There are 3 main areas we need to think about:

 Stopping people being treated unfairly, bullied or treated badly.



2. Making sure staff from any of the groups of people who are often treated unfairly are given the same chances as anyone else.



3. Helping people from these different groups get on with each other.

Each year, we also need to show what work we have done to make sure we are following our plans about treating people equally and fairly.



And every 3 years we make new plans after we have checked how well the old ones are working.

We want to do our job fairly and openly.



We want to get better at what we do and be a better place to work.



We follow rules about how to decide if we take someone to court.

They say:

- being fair and taking people to court when it's needed is really important to help stop people breaking the law
- we must make sure the right person is taken to court for the right crime

Making our decisions well helps get justice (being treated properly and fairly) for everyone.



Because we think it is the right thing to do, we think about treating people equally and fairly in everything we do.

The plans were made in a small group of people from the Community **Accountability** Forum or **CAF**.



CAF includes people interested in our work as well as staff members. **CAF** was involved from the very start of this work.
